## **Preparing a Port for Heavy Weather**

The US Coast Guard facilitates a phased port operations closure to minimize detrimental impacts due to severe weather. The Houston Maritime Complex is the largest complex in the US by tonnage and facilitates approximately \$7.4M in commerce per minute. Re-constituting port operations post-storm is critical to our national economy.

We direct port conditions that roughly align with the National Weather Service's Hurricane Condition establishment. There can be some variability depending on the predictd severity and track of the storm.

Our objective throughout the process is to ensure safety of life and enable swift re-constitution of port operations.
